

GENERAL LIMITED WARRANTY

SPRADLING INTERNATIONAL



Spradling International (as further defined below, "Spradling") provides the following warranty to its commercial customers who purchase products from Spradling in the United States. As used herein, "Spradling" means the seller of the product covered by the applicable warranty, which will be one of the following three corporations: (i) Spradling International, Inc. – South, an Alabama corporation, (ii) Spradling International, Inc. – East, a New Jersey corporation, or (iii) Spradling International, Inc. – West, a California corporation. This limited warranty applies only to Spradling products that are purchased in the United States and are not covered by Spradling's separate Limited Warranties on Marine Products (which covers Marine Grade Vinyls, Compass HB™ Hybrid Marine Flooring, and Navigator Topping).

Subject to the limitations and conditions described herein, Spradling warrants to its commercial customers that products covered hereby will conform to the applicable product description and specifications published by Spradling and will remain free from defects in materials and workmanship for a period of ninety (90) days from the date the products are first shipped by Spradling.

No claims for defects or nonconforming products will be allowed unless Spradling is given immediate notice of such nonconformity after delivery of such products and allowed an opportunity to inspect such products.

Spradling's sole liability (and Buyer's exclusive remedy) for breach of warranty or for negligence or otherwise, is expressly limited at the option of Spradling to one of the following: (a) replacement with the same or a substantially similar product at the agreed point of delivery of any products found to be defective or not to conform to the description and specifications set forth herein, (b) repair of such product, or (c) refund or credit to Buyer the price of such products.

All warranty claims must be submitted in writing within thirty days after discovery of the nonconformity or defect, and Spradling must be allowed an opportunity to inspect the Product under claim.

The warranties set forth herein DO NOT COVER and the remedies set forth herein are not applicable to any of the following: (a) damage or defect caused by application, installation, use or maintenance inconsistent with Spradling's specifications or instruction; (b) degradation due to the presence of amines in adjacent urethane foam cushioning; (c) damage caused by improper installation or failure of the seat and/or trim parts; (d) deterioration due to the use of improper cleaning materials or procedures; (e) staining or degradation due to any agent or cleaner; (f) seam failure due to improper sewing or failure of any of the components; (g) damage resulting from abuse or mishandling; or (h) normal wear and tear.

THE WARRANTIES AND REMEDIES SET FORTH HEREIN ARE THE SOLE AND EXCLUSIVE WARRANTIES PROVIDED BY SPRADLING AND THE SOLE AND EXCLUSIVE REMEDIES AVAILABLE FOR DEFECTIVE OR NONCONFORMING PRODUCTS OR ANY BREACH OF WARRANTY. SPRADLING SHALL IN NO EVENT BE LIABLE FOR CONSEQUENTIAL DAMAGES, LOST PROFITS, OR LOSS DUE TO BUSINESS INTERRUPTION ARISING FROM ANY BREACH OF THESE WARRANTIES, BREACH OF CONTRACT, NEGLIGENCE, STRICT LIABILITY OR ANY OTHER LEGAL THEORY, EVEN IF SPRADLING OR ITS AGENT HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

NOTWITHSTANDING ANYTHING CONTAINED HEREIN TO THE CONTRARY, SPRADLING'S WARRANTIES SHALL NOT APPLY TO ANY PRODUCT IF BUYER ALTERS OR ABUSES SUCH PRODUCT OR REPLACES ANY PART OR PARTS OF SUCH PRODUCT WITH ANY PART OR PARTS NOT PRODUCED, SOLD OR OFFERED FOR SALE BY SPRADLING OR IF BUYER DOES NOT ALLOW SPRADLING THE OPPORTUNITY TO INSPECT THE PRODUCT BEFORE IT IS REPAIRED OR REPLACED.

EXCEPT FOR THE EXPRESS WARRANTIES STATED HEREIN, SPRADLING HEREBY DISCLAIMS ANY AND ALL WARRANTIES EXPRESS OR IMPLIED, AND SPECIFICALLY AND WITHOUT LIMITATION, DISCLAIMS AND PRECLUDES ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

No individual or entity, whether or not employed by Spradling, is authorized to modify any written warranty made by Spradling or make additional warranties binding upon Spradling. Any additional statements, such as those contained in advertising, presentations of promotional materials, or literature of the manufacturer, distributor or dealer, whether oral or written, do not constitute warranties by Spradling and should not be relied upon as a warranty of Spradling. Must show proof of purchase to validate warranty. Not following maintenance instructions voids warranty.
